Assam Women's University established in 2014 by Assam Act No. XXII of 2013, is the only Women University in entire North-East India. It is constituted as a teaching, residential and non-affiliating institution of higher education for young women. It resolves to provide facilities to women for graduate and post-graduate education in applied science, humanities, technology, industry, commerce, social science, health science and management through instruction and training. The university aims to promote research for advancement of knowledge and for that matter to implement the depth of specialization.

The university solemnly intends to provide opportunity to building career and shaping personality so that the graduated students can aim to achieve their desired goal even in their student days and can start the next phase of career as independent entrepreneurs besides settling down in various positions and professions.

Therefore, the university is continuously been upgrading its curriculum in Choice Based Credit System (CBCS) to promote flexibility and innovation. Furthermore, the university has constantly been working on the way towards its capacity building and inclusion of different operational efficiencies in qualitative mode.

B. INSTRUCTION FOR THE CANDIDATES

- Application form is to be filled-up on the university website, i.e., www.awu.ac.in.
- For programmes where entrance tests are not conducted, filled in application forms have to be submitted only after the declaration of final semester results of the qualifying examination.
- For under graduate and post graduate programmes for which entrance tests are to be conducted (*subject to change as per Govt. notification*), applicants awaiting their final results can also apply.
- Candidates shall have to appear before the Selection Committee as per Admission date, time and venue with all the original certificates, mark sheets, PRC and other supporting documents at their own cost.
- Candidates, if selected, shall have to take admission immediately after counselling. A candidate failing to take admission on the day shall have to forfeit the seat.
- Payment of fees has been waived for Academic Session 2020-2021, as per instructions given by Director of Higher Education, Govt. of Assam vide notification No. PC/HE/SOPD/11/2020/10 dated 17th June, 2020. However, Self-Financed Programmes like Master of Social Works (MSW), Master of Physiotherapy (MPT) and MA in Psychology are exempted from this Fee Waiver scheme.
- No separate call letters will be issued to the applicants.**

1. THE UNIVERSITY

The Assam Women's University is the first state women University in the entire North Eastern Region of India which started functioning from the month of September, 2014. The University has been established by an Act (XXII) of 2013 of State Legislature of Assam as a State University vide Notification LGL.149/2011/92 dated 21.08.2013 and is empowered to award degrees as specified by the UGC under Section 22 of the UGC Act 1956 through its own departments. The main objectives of the University are as follows.

- a) To provide for facilities and offer opportunities to women for education in applied arts, technology, industry, commerce, management, applied sciences and social science by instruction, training, research, development and by such other means as the University may deem fit;
- b) To promote research in applied science and arts, technology, industry, commerce, management and social science for the advancement of knowledge and for the betterment of the society particularly with focus on women's perspective;
- c) To devise and implement programmes of education for women in applied science, arts, technology, industry, commerce, management and social science that are relevant to the changing socio-economic needs of the society, in terms of breadth of diversity and depth of specialisation;
- d) To serve as a centre for fostering co-operation and exchange of ideas between the academic and research community on the one hand and industry on the other;
- e) Organize exchange programme with other institution of repute into India and abroad with a view to keeping abreast of the latest development areas of teaching and research.

1.1 MISSION

The mission of the university is to provide a level playing ground for the women of Assam with respect to accessing higher education for promoting their knowledge, competitiveness and skills so as to make them capable citizens to fill up the women talent gap in different spheres of societal, scientific, technological and other areas.



The ultimate goal of the University is to produce 21st century women knowledge and think-tanks to effectively carry forward the women centric opportunities in the state of Assam and to become a matching partner in national and global development.

The campus of the University is located at Rowriah, Jorhat, Assam which is 7 km away from ISBT, Jorhat, 1 km from the Rowriah airport, Jorhat and 7 km from Jorhat



railway station. Jorhat can be reached easily from Guwahati, the gateway to North-East India by bus / train / air.

8. ELIGIBILITY

- Only female candidates are eligible for admission.
- A candidate applying for undergraduate programme shall be at least 17 years of age as on August 1, 2020 (i.e., must have been born before 01-08-2003).
- Selection of eligible candidates for admission to BA in Psychology, Bachelor

of Physiotherapy, MBA, MTTM, MLIS, MPT, MSW, MA in Political Science, MA in English, MA in Psychology and MA in Mass Communication and Journalism will be based on their performance in the entrance test (*Subject to change as per Govt. notification*). For other programmes, selection will be on the basis of merit in the qualifying examination.

8.1 ELIGIBILITY CRITERIA FOR DIPLOMA, UNDER GRADUATE AND POST GRADUATE PROGRAMMES

During the session 2020-21, Assam Women's University offers one post graduate diploma, two under graduate and thirteen post graduate programmes. Admission will be purely on merit basis following the reservation system of the Government of Assam. Intake capacity for each programme will be of 25 Regular Seats and 5 Higher Fee (Endowment) Category Seats except Master of Social Works (MSW), Master of Physiotherapy (MPT) and MA in Psychology, which are fully Self-Finance Programmes. Following are the eligibility criteria of the offered programmes.

8.2 PROCEDURE OF HOLDING THE ENTRANCE EXAMINATION

- For Bachelor of Physiotherapy, questions will be on Physics, Chemistry, Biology and English from 10+2 level syllabus.
- For Master of Physiotherapy, questions will be Bachelor of Physiotherapy syllabus.
- For BA in Psychology, the test will assess candidate's English Proficiency, Reasoning and Basic Arithmetic skills.
- For MA in Psychology, the test will assess knowledge of Undergraduate Psychology facts & concepts along with English Proficiency, Logical Reasoning and Quantitative Aptitude.
- For MBA and MTTM written test, questions will be on Current Affairs, Quantitative Aptitude, Reasoning and English.
- For MLIS written test, questions will be on Reasoning, English and Computer Basics.
- For MA in Political Science, questions of the written test will be on Current Affairs and as per degree syllabus.
- For MA in Mass Communication and Journalism, questions of the written test will be on Current Affairs, North-East Culture, Media, Language Skill, Comprehension / Grammar.
- For MA in English, Entrance test will be conducted on two phases. *Phase-I:* Written Test of total 70 Marks on the History of English Literature and Language. *Phase-II:* Oral Viva of 30 Marks to evaluate the speaking skills and knowledge of the subject.
- For MBA, MTTM and MA in Mass Communication and Journalism programmes, written test will be followed by group discussion and/or personal interview.
- For MSW programme, the mode of conducting entrance test will be notified on a later date. Candidates are advised to visit the university website frequently.

- l) The final merit list will be prepared based on the academic performance of the candidate and the marks scored in the entrance examinations conducted by the respective departments. However, the qualifying marks of the entrance test for the Department of Physiotherapy and Psychology is 50%.

9. ADMISSION PROCESS

9.1. HOW TO APPLY

Applicants should read the information given on the **Online Admission Portal** in the University website, thoroughly before filling up the application form.

9.1.1 OBTAINING INFORMATION BULLETIN AND APPLICATION FORM

The Information Bulletin and the Application Form for different programmes are to be filled up on the University Admission portal, by visiting the University website www.awu.ac.in/admission.html

9.1.2 SUBMISSION OF APPLICATION FORM

All applicants have to apply online and no offline applications will be entertained. If an applicant is interested in applying for more than one programme, she has to fill separate online application forms for each programme.

10. SELECTION AND ADMISSION PROCEDURE

Candidates will have to appear **personally** before the Selection Committee (*subject to change*) at their own expense, on the scheduled date of admission.

10.1 RESERVATION OF SEATS

The University makes provisions for reservation of seats as per Government of Assam norms for eligible candidates belonging to the following categories. Certificates from the competent authorities against each of the reserved categories must be enclosed along with the filled-in application form. Self-attested copies of certificates mentioned against each of the categories must be submitted along with the online application form, the original of which has to be produced at the time of admission.

- a) Scheduled Caste specified in relation to the state of Assam under Article 341 of the Constitution of India. (**Certificate from the competent authority countersigned by the Deputy Commissioner / Additional Deputy Commissioner**).

- b) Scheduled Tribes (Plains and Hills) specified in relation to the state of Assam under Article 342 of the Constitution of India. **(Certificate from competent authority countersigned by the Deputy Commissioner /Additional Deputy Commissioner).**
- c) Other Backward Classes (OBC) / More Other Backward Classes (OBC) specified in relation to the state of Assam. **(Certificate from competent authority countersigned by the Deputy Commissioner / Additional Deputy Commissioner).**
- d) Persons with Disabilities as per provisions of Section 32 under Rights of Persons with Disabilities Act 2016. **(Certificate from competent authority countersigned by the Deputy Commissioner / Additional Deputy Commissioner).**

10.2 ADMISSION OF FOREIGN / NRI STUDENTS

Foreign candidate seeking admission shall forward their application through their respective Embassy / Mission at New Delhi or through the respective Indian Missions abroad to the Government of India /University Grants Commission (UGC) and their candidature shall be considered if they are sponsored / cleared by the Government of India / UGC. Necessary fees shall be charged at the rates prescribed by the UGC for the foreign candidates which is three times of the admission fees in each semester for the respective discipline. Eligibility for admission of foreign students is as per qualification prescribed by the University. A good knowledge of English language is essential.

10.2.1 DOCUMENTS REQUIRED FOR ADMISSION OF FOREIGN STUDENTS

- a) Visa: All the international students will require a student visa endorsed to this Institution for joining full time courses. No other endorsement is acceptable. The visa should be valid for the prescribed duration of the course. Visa is not required for NRI students.
- b) All international students will have to obtain prior security clearance from the Ministry of Home Affairs and the approval of Department of Secondary & Higher Education, Ministry of Human Resource Development Government of India.
- c) A certificate of candidates' proficiency in English issued by the respective Indian Mission abroad and recognized agencies should be submitted.

10.3 ADMISSION

Admission of a candidate to a Programme is subject to the following conditions:

- a) Fulfilment of the eligibility criteria as specified in Eligibility Criteria for Admission
- b) Selection for admission to the Programme.
- c) **Production of all the relevant documents such as pass certificates and marksheets of all earlier examinations with requisite percentage of marks in original and original copies of documents uploaded at the time of submission of the application form.**
- d) Submission of a set of self-attested copy of all pass certificate, marksheets and other the relevant documents.
- e) Submission of the character certificate from the Head of the Institution and Migration certificate (**in original**) from the Board / University last attended.
- f) Submission of a self-attested printout of the filled-in application form.
- g) **Receipt of payment of admission fee in full.**

10.4 PROVISIONAL ADMISSION

- a) If the result of the qualifying examination of a student is awaited at the time of admission, she must produce/submit pass certificate/marksheet with requisite percentage of marks within 30th October, 2020. Such a candidate must submit a proof of taking all the examinations including practical/lab/project/backlog courses of the qualifying Degree/Diploma/Certificate at the time of admission duly certified by the Head of the Institute last attended. If any backlog course or other component remains incomplete after admission, then the candidate will be treated as not qualified for continuation and will be asked to leave the programme.
- b) If a candidate fails to produce / submit any document (such as the completion certificate and mark sheet/transcripts of the qualifying examinations, migration certificate from the Board/University last attended, etc.) at the time of admission, the same must be produced as early as possible but not later than 30th October, 2020.
- c) Candidates failing to produce marksheet or pass certificate with requisite percentage of marks within the specified period will not be allowed to continue her study.

10.5 PERMANENT RESIDENCE CERTIFICATE

All candidates (except foreign nationals) must submit the Permanent Residence

Certificate issued by the competent authority (Deputy Commissioner/District Magistrate/SDO Civil) of the Government.

10.6 GAP PERIOD CERTIFICATE

If a candidate discontinues her studies after the qualifying examination, she shall have to furnish a gap period certificate only from the institute last attended.

10.7 PHYSICAL FITNESS

The candidate shall have to submit a duly filled-in prescribed format (**Annexure I**) along with the application form.

10.8 ANTI-RAGGING AFFIDAVIT

Indulging in ragging inside or outside the University campus is punishable. Students are advised to visit www.ugc.ac.in or www.awu.ac.in for UGC Regulations on curbing the menace of ragging in Higher Educational Institutions, 2009. The students and parents must submit a duly notarised anti-ragging affidavit as per the format given on the website in ~~Annexure III and Annexure IV~~.

10.9 PAYMENT OF FEES

Subject to physical fitness of the candidates, being declared as such by the Medical Officer / Medical Board, an eligible candidate has to take admission on payment of prescribed fees immediately after selection.

Payment of fees has been waived for Academic Session 2020-2021, as per instructions given by Director of Higher Education, Govt. of Assam vide notification No. PC/HE/SOPD/11/2020/10 dated 17th June, 2020. However, Self-Financed Programmes like Master of Social Works (MSW), Master of Physiotherapy (MPT) and MA in Psychology are exempted from this Fee Waiver scheme.

13. HOSTEL

Limited hostel seats across all schools shall be allowed. Other students shall have to arrange their own accommodation till the facility comes up.

14. TEACHING

14.1 CHOICE-BASED CREDIT SYSTEM & CONTINUOUS ASSESSMENT

The AWU has followed the Choice-Based Credit System (CBCS) and Continuous Assessment in a semester. These are the important components of reform in higher education in India. In this Choice based credit system, students are given opportunities to pursue courses of interest across discipline and schools in addition to their major course of interest.

The number of credits in a course is closely related to the number of teaching-learning hours and the flexible curriculum enables students to pursue courses of their interest and obtain inter-disciplinary expertise. Assam Women's University has also adopted the Lecture-Tutorial-Practical (L-T-P) structure which encourages students towards self-learning or learner centric approaches. The students have more opportunities to develop and nurture their creative abilities and are exposed to the methodologies of academic work.

Medium of Instruction: **English.**

14.2 ACADEMIC YEAR

The academic year of the University is from August to July. The academic year consists of two semesters.

14.3 COURSES

During a semester, the students register themselves for a number of courses. A “Course” is a unit of instruction of a subject matter under any discipline carrying a specific number of “Credit Hours”.

14.4. CREDIT HOURS

“Credit Hours” Signify the quantum of work done corresponding to 1 hour of theory class or 2-3 hours of laboratory /field practical every week during a semester in respect of a particular course.

14.5. ATTENDANCE

A student is to maintain a minimum of 75% attendance separately for theory and practical in each course failing which she shall be debarred from appearing in the End Term examination.

15. EXAMINATION

Student performance for both Under Graduate (UG) and Post Graduate (PG) program shall be monitored throughout the semester by continuous assessment. There shall be university examinations (both theory and practical) at the end of each semester. But a continuous evaluation of students will be carried out by the course teachers during the progress of semester. The evaluation scheme for each course shall contain the following two parts.

- a. Internal evaluation carried out during the semester.
- b. External evaluation at the end of the semester.

Internal evaluation shall involve two written tests as notified in the academic calendar. External paper setters are engaged for external evaluation, i.e., end term examination.

16. CLIMATE

The climate of the state is pleasant for most part of the year. The winter lasts for about five months, viz., from October to February. Though summer starts from

March-April, the weather is quite pleasant. There is heavy rainfall during the months of July and August.

17. DRESS CODE

Students of MBA are to dress in navy blue trouser, blazer and sky-blue shirt. The students should dress in college blazer during games, sports and other special occasions. Students of Physiotherapy are to dress in azure blue kurta, white salwar and dupatta with black winter wears. Students are to use white aprons during laboratory practical and clinical postings. For attending university functions and within the campus, every student is expected to be modestly dressed. Students of Fashion Design & Technology are to dress in white kurta with blue trouser for summer wear and olive green trouser and coat with off-white shirt for winter as well as formal wear.

18. DISCIPLINE

All students are to maintain discipline and proper scholastic atmosphere during their stay at the University. On admission, students must acquaint themselves with the University and hostel rules and regulations. Ragging is completely banned in Assam Women's University. Any student found involved in ragging shall be liable for stern disciplinary action as per the UGC Regulation on **“Curbing the menace of ragging in higher educational institution, 2009”**.

19. STUDENTS' WELFARE

19.1 SPORTS, RECREATION, SOCIAL SERVICE

The University shall gradually provide facilities for games and sports, music, study circle, drama and other co-curricular activities for overall personality development of the students admitted.

19.2. MEDICAL FACILITIES

The available facilities at the Assam Agriculture University, Jorhat shall be shared.

19.3. STUDENTS MAGAZINE

There is provision for publishing a magazine to encourage creativity of the students. The students are to pay the magazine fee at the beginning of each academic

year. The first issue of the University wall magazine 'Surujmukhi' came out in September, 2014.

19.4. BUS FACILITY FOR STUDENTS

Bus service is available on payment basis for commuting between Jorhat Town and University Campus.

20. REFUND OF CAUTION MONEY

Refund of caution money shall be made to a student after her release from the University. The claim of caution money shall not be entertained beyond a period of one year from the date of release.

Release of caution money shall be made against application in prescribed form and production of release order. The caution money shall not be refunded if a student leaves the college without prior permission and/or does not join and attend any class after admission.
